


Investments

Up to 40% of the SEB III pillar pension fund 65+ assets are invested in instruments with equity risk, and the rest is invested mainly in debt securities and deposits. When making investments, including investing in instruments with equity risk, the management company makes sure that the risk level of the investment portfolio of the fund corresponds to the risk profile of the fund. The goal of the fund is maintaining the value of pension assets.

This means that the long-term rate of return of the money invested in the pension fund should be equal to the rate of inflation.



Due date Breakdown






